

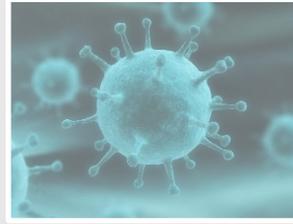

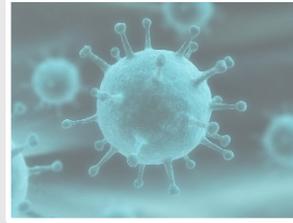

COVID-19 Dialysis Unit Strategies

- ▶ We contribute our success to the following:
 - ▶ We were proactive.
 - ▶ Evening of Wednesday, March 11, we contacted all patients that were to run on Thursday and did a prescreening.
 - ▶ Thursday March 12, we contacted all patients that were to run on Friday and did a prescreening.
 - ▶ Along with the prescreening, we implemented the no-visitor policy, placed signs around the unit, and positioned an employee at the entrance for screening patients we could not reach by phone.
 - ▶ During those first runs, we handed out the CDC flyers on COVID-19, signs and symptoms, what to do when sick, and handwashing.

COVID-19 Dialysis Unit Strategies (cont.)

- Friday, March 13
- Staff started screening temperatures in and out with signs and symptoms; We followed the hospital's plan and masked within 6 feet of patients and removed ancillary staff off the dialysis floor.
- We started planning for isolation rooms to be available for known exposures or signs and symptoms patients.
- We looked at different options for treatment. We decided it would be best to move patients around on Tuesday, Thursday, and Saturday. Last shift being COVID-positive. Treatment floor was empty by 3 p.m. and then the COVID shift did not start until 3:30 p.m.



Exposure COVID-19 Plan in Action

- ▶ March 24: First confirmed case at local meat packing plant—Smithfield
 - ▶ This meat packing plant's health insurance plan is through our hospital, so we knew we would see patients and potential exposures.
- ▶ From this day forward we followed:
 - ▶ Mayor's and Governor's press conferences
 - ▶ Social media and local news outlet coverage of where COVID-positive cases were located in our city and counties.



Exposure COVID-19 Plan in Action (cont.)

- Social workers worked on updating places of employment for family members and modes of transportation.
- We contacted the transportation company when their drivers had tested positive; We did not wait to hear if one of our patients were on their route.
- We contacted nursing homes when they had positives to follow up on the patients we had in their facilities.

Conclusion

- We found that by being proactive and having a team that could listen to press conferences, social media, and news reports, along with calling businesses, helped us to have a head start on quarantining patients.
- We did not have any staff members test positive.
- 6 patients tested positive: 1 home dialysis patient and 5 in-center patients.
- To date, we have tested about one-half of the in-center patients, with 5 positive and 48 negative; The current patient population is 103.
- Our state has flattened our curve by 75 percent. The main county affected opened back up from a social distancing order on May 29.
- We are continuing to monitor closely after all restrictions are lifted.





